3. That the school shall comply with clause 14 of order No.F.DE/15(56)/ACT/2009778 dated 11.02.2009 in r/o maintenance of DRF. School also ensure to follow FN-21 "Accounting by schools" as issued by the Institute of Chartered Accountants of India (ICAI) for proper accounting treatment.
4. That the school shall comply with the provisions of section 10(1) Read with Rule 125 of DSEAR, 1973.
5. That the school shall observe the relevant provisions of RTE Act, 2009, DSEAR 1973 and directions/instructions issued by the Department from time to time.
6. That the school shall comply with the orders/guidelines of DoE and judicial pronouncement w.r.t. utilization/maintenance of school funds.
7. That the school shall comply with the orders dated 07.11.2017/guidelines of DoE and judicial pronouncements w.r.t. safety of the students and shall take all necessary steps to this effect.
8. That the school shall recruit the sufficient no. of PGTs to meet the prescribed qualifications as per RRs of DSEAR, 1973 on regular basis within 02 months and submit the documents to the district authority.
9. That the school shall appoint the EVGC staff on regular basis as per the provisions of DoE and submit the documents within 02 months to the district authority.
10. That the school shall appoint the 2nd Special educator and submit the documents within 02 months to the district authority.
